Olena Gordon

Doctor Olena Gordon was born and raised in a small town in Ukraine. After graduating from Ternopil State Medical University in 2001 she went through residency in Ternopil, Ukraine. Shortly afterward, she immigrated to the United States with a 2-year-old daughter.

After several years of learning English and studying and passing Medical Board exams, she began residency at St. Mary's and Elizabeth Medical Center in Chicago. Since completing the residency in 2013, she has practiced as a Family Medicine physician.

She is a small business owner of a Family practice in Niles and is an active member in the Ukrainian community. In 2020 she was elected as president of UMANA (Ukrainian Medical Association of North America) IL branch. Upon the beginning of the war in Ukraine, she co-founded UMANA IL Medical relief project which is still going strong, having shipped 350 tons and estimated \$27 Million of medical supplies and equipment.

Cassandra Ma

Dr. Cassandra Ma, Psy.D., is the Founder and Executive Director of Reclaim13, a non profit organization dedicated to providing healing services to survivors of sexual abuse, trafficking, and exploitation. Dr. Ma received her doctorate in clinical psychology and post-doctoral fellowship in marriage and family therapy at the

Family Institute at Northwestern University, where she joined the staff team teaching and coordinating the Bette D. Harris Family and Child Clinic.

Reclaim13 provides services that focus on three broad areas: healing, prevention, and engagement. The healing programs include two residential homes: Cherish House, a home for commercially sexually exploited youth, ages 10-17, and Courage House, a transitional living program for trafficked survivors, ages 18-25. The Child and Family Program, serves survivors of child sexual abuse and exploitation and their families by pairing them with trained mentors and opportunities to meet with licensed therapists who specialize in trauma informed therapy. The prevention and engagement initiatives equip individuals from communities all over Illinois to help raise awareness and educate the public in the fight to end the cycle of child sexual abuse and exploitation.

In 2017, Dr. Ma and Reclaim13 were recognized by the Office of the U.S. Attorneys for the Northern District of Illinois for their work with victims of sex trafficking. She has been recognized by the Illinois Department of Children & Family Services for her compassion, dedication and commitment to the children and families of Illinois and has served on various advisory boards, including the Illinois Children's Justice Task Force, and College of DuPage's Human Services.

Susana Mendoza

Prior to serving as comptroller, Susana was the first woman elected Chicago City Clerk. In her first term as Chicago City Clerk, Susana successfully transitioned 1.3 million customers away from an inefficient and archaic annual Chicago City Vehicle Sticker sales program dating back 105 years.

She also took on the horrendous puppy mill industry and won. Working closely with animal rights groups, primarily the Puppy Mill Project, Clerk Mendoza spearheaded and passed the Companion Animal and Consumer Protection Ordinance.

Before City Clerk, Susana Mendoza proudly served six terms as a Democratic member of the Illinois House of Representatives from 2001 to 2011 for the 1st District. Elected in 2000 as the youngest member of the 92nd Illinois General Assembly, she was publicly recognized for her leadership and legislation on social services, education, law enforcement, job creation and animal welfare. She was a leading sponsor of HR 1650 which created the panel to impeach former Governor Blagojevich and she served as an active alternate member of the impeachment committee.

Gayle Littleton

Littleton was named the company's general counsel in November 2020. She serves as the top legal advisor to Exelon's Board and senior management, and she oversees the company's legal and corporate governance

Prior to joining Exelon in 2020, Littleton was Co-Chair of the Investigations, Compliance and Defense Practice at Jenner & Block, LLP, where she led complex investigations and litigation matters.

Littleton was Chambers USA-ranked in white-collar investigations and was named on the Global Investigations Review's list of 100 "Women in Investigations" globally. She served on Jenner's Management Committee and co-chaired the firm's Women's Forum Steering Committee, comprised of women partners across offices. Before joining Jenner, Littleton was an Assistant U.S. Attorney with the Department of Justice for over a decade, where she prosecuted complex federal cases in the Northern District of Illinois in Chicago and in the Northern District of Florida. Littleton is a former law clerk to the Honorable Gerald W. Heaney of the U.S. Court of Appeals for the Eighth Circuit and a former law clerk to the Honorable Joseph L. Tauro of the U.S. District Court for the District of Massachusetts.

Littleton received her law degree, magna cum laude, from Cornell Law School and her Bachelor of Arts degree from Stetson University.

The JOB1 Summer Internship Program was created 20 years ago, in 2003, when the Rotary Club of Chicago was looking for a vocational services program that would deliver significant community value and that would engage Rotary members as well as the community it serves. Then, in 2005, JOB1 started as JobStart, a part of the City of Chicago's KidStart Corporate Initiative. Rotary has remained a collaborative partner with the city and Chicago Public Schools and its Career and Technical Education department.

As the signature program for ROTARY/One, JOB1 prepares City of Chicago High School 11th grade and graduating seniors, who are sixteen and over, for the workplace by providing job readiness training, as well as, substantive paid summer internship opportunities with local businesses and not for profits in the Chicago area.
